Requirements for theses:

- theses are provided by e-mail only. The volume of theses – 2-3 full pages of A4 format (297x210 mm), including figures, tables, references;
- the list of references should be placed at the end of the text of the theses;
- links in the text are placed in square brackets;
- theses should be presented in Microsoft Word (.doc format), Times New Roman, 14 pt, Line spacing – 1,5; Text margins: top – 20 mm, bottom – 25 mm, left – 20 mm, right – 20 mm;
- formulas should be presented in the Math Type or Microsoft Equation.

Submitted materials are published in the author's edition.
